- e) Preparation of Sansad wise Yearly Health Plan

In this regard, you are further requested to advise the DNO, CHCMI to monitor the implementation process from District level and coordinate with Joint BDOs. Similarly, Joint BDOs should ensure the effective implementation of Portals accordingly.
