Intending Bidder will get the Beneficiary details from e-tender portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per Beneficiaries Name & Account No, Amount, Beneficiary Bank name (ICICI Bank) & IFSC Code and e-Proc Ref No. Intending bidder who wants to transfer EMD through NEFT/RTGS must read the instruction of the Challan generated from eProcurement site. Terms and Conditions are as follows:-

Intending tenderers are to inspect the site of work and get acquainted with the local condition and difficulties in execution for which no objection will be entertained in future.

The credential should be submitted/uploaded at least 40 % of the amount put to Tender supported by final payment Certificate and Completion Certificate within the last 5 years in the similar nature of single work & completed the work successfully.

The Credential should be in the name & style of the intending tenderers only, and not in the name and / or style of any of the Partner(s).

- 9. Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder.

- 11. The scope of Sub-Contracting is not allowed strictly by any way.
- 12. Rate to be quoted must be inclusive of all incidental charges of Income Tax, GST, Duties local taxes. Toll tax, Ferry and escalation of any materials, carriage or labour that the schedule rates and should be completed with all labour and materials as per details of item.
- 13. The materials brought at site for execution of work by the contractor should be approved by the undersigned or JE concern before use. Rejected materials, if any, should be removed from the site forthwith.
- 14. Before starting the work the work site must be dressed and cleared by cutting all sorts of jungle, shrubs etc and after completion of work the contractor will have to clear the site for which no extra payment will be made.

The Additional Performance Security will be forfeited if the work not executed properly as per schedule and specification within stipulated time.

- 23. Measurement of materials will be as per specification of schedule and payment will be made on net volume.
- 24. Any authority given by the undersigned for any alteration or addition or omission for the work shall not vitiate the contract by the contractor at the accepted rate.
- 25. Before the deadline for submission of bids, the Employer may modify the bidding documents by issuing addenda.
- 26. A printed letter Head Pad of the concerned agency must submit with the tender.
- 27. Affidavit attested by Notary Public should be uploaded with the tender documents. [Format enclosed with SBD].
- 28. Acceptance of lowest tender is not obligatory & the undersigned reserves the right to accept any tender or to reject any or all tenders without assigning any reason and to split up tendered works to more than one contractor in the interest of speedy execution of the scheme.
- 29. Time is the essence of contract. The successful contractor must complete the work within the time specified for completion. No extension of time will be allowed except in special case. If any contractor falls to complete the work within the stipulated time, the work order issued in his/her favour may be cancelled without assigning any reason therefore. The undersigned may also proceed to get the balance work completed by any other means including through other contractors. The excess expenditure if any due to such a step would be recoverable from the unpaid bills/earnest money/security deposit/Additional Performance Security deposit of the agency. - 34. Even though the bidders meet the above qualifying criteria, they are subjected to be disqualified and legal action may be taken if they have:

 - (iii) Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices and could not furnish rational justification for it to the Employer.
