- 1 In the event of e-filing intending bidder may download the tender documents from the website [www.wbtenders.gov.in](http://www.wbtenders.gov.in) in directly by the help of digital signature certificate and the cost of tender documents and the earnest money may be remitted through online following the process described in G.O. No. 3975-F (Y) dated 28.07.2016 & same may be documented through e-filing.
- 2 Technical Bid and Financial Bid both will be submitted online concurrently duly digitally signed in the website [www.wbtenders.gov.in](http://www.wbtenders.gov.in) as per time scheduled stated herein under. The documents submitted by the bidders are to be properly indexed & self-attested positively.
- 3 The financial offer of the prospective tenderer will be considered only if the tenderer qualifies in the technical bid, the decision of the undersigned will be final and binding on all concerned and no challenge against such decision will be entertained.

**Tender fees and Earnest Money Deposit :**

- 1 The amount of earnest money and the Cost of Tender Form to be remitted online either by "Net Banking" ( having their account any listed bank with such facility ) through ICICI bank payment Gateway, or through RTGS/NEFT using online prefilled challans generated in this system of State Government e-Procurement portal [www.wbtenders.gov.in](http://www.wbtenders.gov.in) ( vide Memorandum No. 3975F (Y) dt. 28.07.2016 of W.B. Finance Department.)

**Refund / Settlement Process for EMD :**

- 1 After opening of his / her bids and technical evaluation of the same by the Tender Inviting Authority declared the status of the bid as successful or unsuccessful which will be made available along with the details of the unsuccessful bidders to ICICI Bank by the e-procurement portal through web services.
- 2 On receipt of the information from the e-Procurement portal, the Bank will refund through an automated process the EMD of the bidders disqualified at the technical evaluation to the respective bidder's bank accounts from which they made the on-line EMD transaction. Such refund will take place within T+2 Bank working days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal by the Tender Inviting Authority.
- 3 The Earnest Money of all the unsuccessful Tenderers deposit in favour of the Pradhan, Tiluri Gram Panchayat, Tiluri, Bankura will be refunded as per G.O. No. - 3975-F (Y) dated 28.07.2016. In case of Successful Tender, the Earnest Money deposited by the Tenderer will be released after successful completion of the work. The Security deposit @ 10 % of the bill value will be deducted from the bill at the time of payment as Security Money for performance of work .
- 4 If the e-tender is cancelled, then the EMD would be reverted to the original bidders account automatically after such cancellation order is affected online by the Tender Inviting Authority.

**Eligibility criteria for participating e-tender :**

- 1 The bidders shall have satisfactory completed as a prime agency during the last 5 years from the date of issue of this notice one work of similar nature under the authority of State / Central Govt., State / Central Govt. under taking, Statutory bodies constituted under the statute of the Central / State Govt. i.e. Gram Panchayat, Panchayat Samity, Zilla Parishad and having a magnitude of 40 ( forty ) % of the amount put tender. The completion certificate and detail communicational address of the client must be indicated in the credential certificate & it is must be self attested. ( Gram Panchayat can see Original documents if necessary )
- 2 P. Tax deposit challan for current financial year , PAN Card, upto date GST number with latest GST return, Last 3 Years IT return, Trade Registration Certificate / Licencce from local body, PT Enrollment Certificate , Credential/Completion Certificate and Work order has to be accompanied with the technical bid document, all documents must be self attested. ( Gram Panchayat can see Original documents if necessary )
- 3 Registered Partner Ship Deed in case of partner ship firm has to be submitted. The Company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for an behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of such company or the partners of such firm to upload such tender.
- 4 Joint venture will not be allowed.
- 5 The tenderer shall established field testing laboratory equipped with requisite instrument and technical staffs according to the requirements of works to be executed. All material test report of this work should be submitted at the time of implementation by the contractor.
- 6 Payment will be made as and when fund is available from the concerned source. No claim whatsoever for delay in payment, if any will be entertained. Maximum 2 ( two ) nos. bill ( including final bill ) between 1 lakh to 5 lakh & Maximum 3 ( three ) nos. bill ( including final bill ) above 5 lakh will be paid for this work. Contractors are requested to quote their rate accordingly.
- 7 No arbitration is allowed in this contract.
- 8 10 (Ten) % value of the work will be retained as security deposit which will be released after 6 (Six) Months from successful completion project. Agencies have to arrange land for direction of Plant & Machineries, storing of materials labour shed, Lab rotary etc. water and electricity at their own cost and responsibility.
- 9 No material will be issued from this department.
- 10 Constructional labour welfare cess at @ 1 % of the bill value will be deducted from every bill.
- 11 Contractors shall have to comply with the provisions of A) the contract labour ( regulation Abolition ) Act. 1917 B) apprentice Act 1961 & C ) Minimum wages Act. 1948 of the notification there of or any laws relating there to and the rules made and order issued there under form time to time.
- 12 The schedule of rates : as given in BOQ.
- 13 During scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect / manufacture / fabricated, that bidder would not be allowed to participate in this tender and subsequent tenders and that application will be rejected without any prejudice. Penalty will be imposed as per existing Govt. Rule.
- 14 The authority reserves the right to cancel the NIT due to unavoidable circumstance and for the no claim will be entertained.
- 15 Bids shall remain valid for a period not less than 120 ( one hundred twenty ) days from the last date of submission of Financial Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
- 16 Before submission of tender, the tenderer shall have to acquaint by actual visit to the site as regards prevailing conditions and tenderer submitting tender shall be deemed to have done so. He must acquaint himself with local conditions of labour, material, transport, electricity, water, Panchayat regulations etc. no plea / complain about the site will be entertained afterwards.

- 17 It will be contractor's responsibility to keep the road open to all kind of traffic during the execution of work. No Claim what-so-ever will be entertained for idle labour, establishment cost of hire & labour charges of tools & plants etc. at any circumstances.
- 18 Time is the essence of contract. The successful Tenderer must complete the work within the time specified for completion. No extension of time will be allowed except in special case. If any Agency fails to complete the work within stipulated time, the Work order / Supply order issued in his favour will be cancelled without assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other Agency. The excess expenditure, if any, due to such a step would be recoverable from the unpaid bills / Earnest money deposit / security deposit of the Tenderer.
- 19 The authority shall straightway reject the price-bids which may appear to be absurd in terms of rates and with the mala-fide intention of competition only. With holding the offer of price en-masse shall be construed as a deliberate action as to jeopardizing the speedy execution of the scheme and such bidders shall be black-listed for the future course of Tenders of this local Self Government body.
- 20 The rate should be quoted in percentage both in figures as well as in words. If the tender less amount is more than 15 % than the estimated amount put to tender, an analysis of the tendered amount would have to be submitted with the Financial Bid.
- 21 Any rate above than the schedule rate of work will not be ordinarily entertained.
- 22 The successful Tenderer will have to start the work within seven days from the date of issues of supply order / work order after execution of formal agreement as per rule and will have to complete the work within the time allowed for completion. The successful Tenderer must be execute the work by the specified materials duly approved by the undersigned, otherwise the work order / supply order will be treated as cancelled for supply of poor quality materials or bad workmanship.
- 23 The ST / IT / Royalty / Cess / GST at the prescribed rate will be deducted at source as per Govt. Rule.
- 24 The proof of depositing Royalty / Cess to the concerned authority is to be submitted while producing bill to the undersigned ( in case of procuring materials for which the Royalty or Cess is required to be paid to the Govt. as per rule ). The document / proof in this regard shall be duly countersigned by the concerned agency.
- 25 This Notice shall form part of terms and conditions of tender and the Participants shall be bound to abide by them.
- 26 Claim for idle labour from contractor will not be entertained under any circumstances. No claim will be entertained for any increase in Railway freight and market price.
- 27 The contractor shall pay of charges & fees legally payable for act out of their works & hold the employer free of such cost.
- 28 Contractor has to execute the work on strict supervision of the NS, EA & GP Authorities.
- 29 Decision of Pradhan, Tiluri Gram Panchayat will be final & binding on contractor in case of any dispute.
- 30 Contractor has to arrange at his own cost, to display sign. Board at the site before starting the job indicating the following.
  - i) Name of the Contractor.
  - ii) Name & Nature of the Contract.
  - iii) Estimated amount.
  - iv) From which fund the work is being executed.
  - v) Time of completion.
- 31 All tools, plants & machineries including vibratory, road roller etc. required to execute the Contract, has to be arranged by Contractor at his own cost.
- 32 The works are time bound project & time of completion of work should be strictly followed.
- 33 All disputes, arising out of this NIT, comes under the jurisdiction of Calcutta High court only.
- 34 Bidder should submit his / her declaration by non-judicial stamp paper along with Affidavit by a sample form attached in this notice.
- 35 **Defect Liability Period clause of GOWB will be strictly adhered in this tender.**
