No demand draft for EMD or tender participation fee would be entertained) (Any source of postal delay of other means cannot be entertained after last date.

Eligibility criteria for participating in e-tender

2. The bidder shall have satisfactorily completed as prime agency during the last 3 years from the date of issue of this notice at least one work of similar type /or as specifically mentioned in the credential column under the authority of State/Central Govt under taking Statutory bodies constituted under the statute of the State/Central Govt and having a magnitude of 60(Sixty)% of the amount put the tender. The completion certificate and details communicational address of the client must be indicated in the credential certificate (Non-Statutory Documents).
3. Self attested P.Tax certificate deposit Challan for up to date, PAN Card, VOTER card, AADHAAR Card , Trade License/Trade Registration certificate (FY 2025-2026), GST Registration Certificate& Last Return has to be accompanied with the technical Bid document (Non-Statutory Documents).The agency should also have to deposit the IT return certificate for the last 3(three) financial years.
4. Registered Partnership in case of partnership firm has to be submitted. The Company shall furnish the Article of Association and Memorandum . 28. The successful tenderers will have to procure Non-Judicial Stamp paper in his / her won cost.


