Prodhan on behalf of Atharobanki Gram Panchayat *under* Canning-II Panchayat Samity, South 24 Parganas invites e-tenders from the intending experienced bonafide elig, SL NO-ible resourceful outsiders and working contractors/agencies having experience in relevant nature and magnitude of the constructional work mentioned as above.

2. This is an e-procurement two bid tender. The intending bidder will have to download the tender documents from the website: <http://wbtenders.gov.in> and submit bid digitally signed in following manner:

a. Technical Bid should contain document of earnest money & deposit receipt of documents cost, technical documents in the form of scanned copies of a) Trade License upto date, b) Valid 15 digit Goods and Services Tax payer Identification Number (GSTIN) registration Certificate (bidder's name only), & latest filled GST return c) Professional Tax Challan up to date, d) Pan card, e) latest I.T. return, f) e-mail ID, g) credentials certificate of similar nature of job as mentioned above. Credentials as a sub-contractor will not be considered. All documents submitted must be self-signed (with seal) with the remarks "submitted by me".

b. Financial Bid should contain the financial offer BOQ (Above/Below/At par) to be submitted online. The bidder will have to quote rates in figures and words. **If the rate is more than 5 percent less from the schedule of rates, then a detail rate analysis must be submitted.** Bids shall remain valid for acceptance for a period not less than 90 (NINETY) days after opening of financial bid. Bid valid for a shorter period shall be rejected.

3. Contractors/ agencies are requested to observe the required credential of a single work order as a prime contractor. If any agency found submitted bid with below or lapse credential the tender will not be accepted. If any agency found submitted bid with false credential, the bid will not be accepted and action will be taken against him.

4. Only bidders can lodge or issue any complain regarding comparative statement or any technical matter within 48 hrs of opening of technical bid. Unless no complain will entertain by the undersign.

5. Any elected member of ATHAROBANKI Gram Panchayat *under* Canning-II Panchayat Samity jurisdiction and/or any blood relative of the GP member are strictly ineligible to participate as bidder.

6. The intending tenderers shall have to furnish original completion certificate along with the payment certificate & Bank Statement if required of similar works of sufficient magnitude as and when that will be demanded by the tender inviting authority.

7. The TIA (Tender Inviting Authority) shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the TIA shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information related to the tender. The TIA shall not be responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders due to local issues.

Counter foil/ bank receipt should be uploaded on e-portal. BANK DRAFT/ PAY ORDER will not be accepted.

10. Earnest money (as indicated in the corresponding column of the work in the annexed sheet) should be deposited in the Savings Bank Account No. 5025011001046 of A/C PRODHAN ATHAROBANKI GRAM PANCHAYAT (IFSC Code: PUNB0RRBBGB)) through RTGS/ NEFT or Fund Transferred Process only in favour of PRODHAN, ATHAROBANKI GRAM PANCHAYAT from bidder's account only. BANK DRAFT/ PAY ORDER will not be accepted.

11. Successful tenderer/s must have to execute a formal deed in Panchayat Samity agreement form within seven days from the date of acceptance of the tender, failing which action will be taken as per rule.

12. Tenderer/s shall be bound to execute any excess and supplementary works as may be ordered by the TIA at the accepted rate of prevailing schedule of PWD/PW(R) D, Govt. of W.B. at the time of tender submission.

13. The time is the essence of contract. Duration of execution of roads & tubewell related works for 30 days only and building related works for 60 days only. Otherwise the unsigned may cancelled the work agreement.

14. All tools and plants and implements required for the construction of the work, will have to be supplied by the contractor at his/ their own cost.

15. The applications of the bidder, who could not complete the works entrusted to them in past to the full satisfaction of this Panchayat Samity, will not be considered.

16. 1% Labour Welfare Cess (vide P & R.D. Deptt. No. 5794 (21)-RID (RIDF)/1A-1/2006 dt.9.10.2006) will be deducted from the bills.

17. Information Board will be affixed at site at his own cost.

18. Bid will be guided by the order issued by Finance Department Vide Memo No. 925-F(Y) dt. 14.02.17

18. 10% of Additional Performance Security money will Be deposited if the tendered value less than 20% or more.

20. Award of Contract: The accepting authority does not bind him-self to accept the lowest tenderer L1 and reserves the right to reject any or all of tenders received, without assigning any reasons. 21. The unsuccessful EMD of the L2 bidder will be released after the start of work. The EMD of L1 bidder will be returned after successfully completion of the said work. The Security Deposit will be released after the successful completion of the security period which will be 180 days from the date of completion of the above work. No partial Security Deposit will be released under any circumstances.
