Annexure-B**Terms & Conditions :-**

1. E tender are hereby invited by the undersigned from the bonafide and experienced contractors, registered co-operative societies formed by unemployed Engineers and Labour Co-operatives , general suppliers having credential of 60% of similar type of work. They have to abide by the following conditions:

a. Submission of Tender Fee and EMD Only by Form 5 (Miscellaneous Receipt) Issued by Dilakash Gram Panchayat. on and from 10/12/2025 to 09/01/2026 (from 11 AM to 2 PM) (DD,NSC are not allowed) b. Scanned copy of the same will have to be uploaded in the wbttenders.gov.in portal through Fee/Prequal/Technical folder of DSC token.

2. BID submission on online mode will be started on and from 10/12/2025 At 15.30 PM to 09/01/2026 (up-to 12.30 PM) The BID opening date is on 11/01/2026 (At 12.30 P.M.)

3. Time is essence of contract. The successful contractor must complete the work within the time specified for completion. No extension of time will be allowed except in special case. If any contractor fails to complete the work within the stipulated time the work order issued in his favour will be cancelled without assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other contractors. This is apart, any other measure the undersigned may take, including blacklisting of the contractor(s), forfeiture of earnest money.

4. Earnest money noted against the name of work @2.00 percent of the value of the work will have to be deposited in the form of Pledge Nationalized Bank draft in favour of the undersigned. Engineer's Co-operative Societies will not be required to deposit any earnest money.

5. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Dilakash Gram Panchayat OR the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after 3 months in all cases except ISGPP Block Grant where it will be released after 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.

6. The rate should be quoted in percentage both in figures as well as in words. If the tendered amount is less than 15 percent of the estimated amount, an analysis of the tendered amount will have to be provided.

7. Audit report of last financial year will have to be submitted in case of Engg. Co-op and Labour Co-op Societies. The tender forms are to be received by the Chairman or Secretaries or any member of the Society having proper Power of Attorney.

8. All works will have to be done according to specification and drawing approved by the authority and as per direction of the Block Development Officer, Jangipara, Hooghly.

9. No consumable materials will be supplied to the agency for any work from the Office of the undersigned. Agency will be responsible for procuring all materials required for proper execution of work at his own cost.

10. All rates shall be inclusive of all charges, royalty, tool charge, carriage etc.

11. Any rate above 5 percent of the scheduled rate of work, will not be ordinarily entertained.

12. The successful tenderer will have to start the work within seven days from the date of issue of work order/supply order after execution of formal agreement as per rule and will have to complete the work within the time allowed for completion.

13. Acceptance of the lowest tendered is not obligatory and undersigned reserves the right to accept or reject any or all the tenderer without assigning any reason what so ever and also to split up the tendered work to more than one contractor in the interest of scheme execution.

14. Amalgamation of unemployed Engg. Co-op. in any form should not be allowed towards counting of eligibility in participation of tender.

15. CESS/IT/GST/SD Money at the prescribed rate will be deducted at source.

16. This notice shall form part of terms and condition of tender and tenderer shall be bound to abide by them.

17. Before submission of the tender contractor must visit the work site to judge the local condition from all corners and no plea/complain about the site will be entertained afterwards. It will be presumed that the agency offered the tender after reviewing entire position of the worksite.

18. Separate tenders should be submitted in similar way for each work or group of work.

19. All working tools and plants and implements required for the work are to be arranged and supplied by the successful tenderer, at his cost.

20. The successful tenderer will have to abide by the provision of West Bengal Contract Labour (Regulating and abolition) Rules 1972 as will be from time to time. If no labour license is obtained and produced by the contractor. Payment will be liable to be withheld.
