Terms & Conditions :-

- Cost of Tender Form (non-refundable) has to be paid in NERT/WFOS only.
- Bidders must submit attested photocopies of valid VAT, GST registration Certificate (if any), last three years Income Tax Return, Profession Tax Registration Certificate with current chalan and Trade Registration Certificate/ license from local bodies as the case may be.
- Bidders must submit 60% Credential in similar nature of work during last three years.
- In case of bid/tender emanating from cancellation of bidders, entire tender process will be cancelled.
- Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special consideration will be accorded to any bidders.
- Bidders will get necessary drawings with the Tender Form. All documents i.e., drawings Tender Form signed by the Bidder must be submitted in Sealed Tender addressed to Pradhani, Guma-I Gram Panchayat, VIL- Nalbedi Taluqa, PO- Guma, PS-Jachkenagar, District- North 24 Parganas.
- Earnest money should be deposited through NERT/WFOS in favour of the Pradhan, Guma-I Gram Panchayat and will be refunded/forfeited as the case may be.
- Successful Bidder(s) will be required to lodge security deposit (3% of the total value of the work as quoted by him) as performance security.
- WFOS and Labour Cost will be deducted as per existing rates fixed by the respective department of the government. GST will be charge as per Government Order.
- Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
- Site visit may be done by the bidders at their own cost.
- Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
- The Bidder(s) have to submit rate analysis for the items where the quoted rate either below or above 5% than the estimated cost.
- Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.

18. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.

19. Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc. GST & any other Govt. Deduction will be applicable as per Govt. Rule.
