The pre-qualification documents alone will be opened for evaluation and selection of qualified bidder on 24th January, 2025 at 18-00 Hours by the Executive Officer, Khejuri-1 Panchayat Santhly in presence of bidders present. Name of the qualified bidders will be displayed in the office notice board.

The financial bid documents of the technically qualified bidders will be opened after the evaluation of technical bid announced and the other bid documents will be unopened. No separate intimation will be given for this, unless the above date is changed. If the office happens to be closed on the date & time for opening of tender as specified in NIT the date will be on the next working day at the same time & venue unless and otherwise announced anything. No individual intimation will be given.

Panchayat Santhly Authority reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

THE ELIGIBILITY CRITERIA ARE GIVEN BELOW :-

1. The applicant in the same name and style as prime contractor should have successful completed at least one contract of similar nature of Civil Engineering work to a value of 50% of estimated cost in a single tender completed within last 5 years, from the Govt. / Semi Govt. Organizations.
2. The contractor should have sufficient technical manpower, tools and plants to complete the work.

3. GST, Sales Tax/VAT, I.T. (PAN Certificate, and I.T. Return submitted for the last financial year); Vat registration certificate with up to date return; and P.T. clearance certificate up to date.
4. All duties, taxes, royalties, cess, including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996, toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills. All deduction will be made as per existing Government Rules & Regulation.



5. The intending bidders are requested to inspect the site of the proposed construction before quoting their bid.
6. Security deposit will be refunded after completion of defect liability period i.e. 6 months for building, one year for concrete road , 6 months for repair of road and 6 months for Street light & Solar Submersible Pump after satisfactory completion of work. In case of failure to complete work within the stipulated time the security deposit will be forfeited without assigning any reason therefore.
