1. 2. Eligibility criteria for participating e-tender:

The bidders shall have satisfactory completed as a prime agency during the last 5 years from the date of issue of this notice at least one work of similar nature under the authority of State/Central Govt., State/Central Govt. under taking, Statutory bodies constituted under the statute of the Central/ State Govt. and having a magnitude of 60% of the amount put tender. The completion certificate, Work Order copy and detail communicational address of the client must be indicated in the credential certificate.

3. P. Tax deposit challan for the year of 2022-23, PAN Card, IT (21-22, 22-23, 23-24) GST Registration Certificate has to

be accompanied with the technical bid document. (Non-Statutory Documents)

4. Registered Partner Ship Deed in case of partnership firm has to be submitted. The Company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for an behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of such company or the partners of such firm to upload such tender. 17. Before submission of tender, the renderer shall have to acquaint by actual visit to the site as regards prevailing conditions and tenderer submitting tender shall be deemed to have done so. He must acquaint himself with local conditions of labour,

22. If the extension of time not granted the work order may be cancelled without showing any further reason.

25. The proof of depositing Royalty / Cess to the concerned authority, is to be submitted while producing bill to the undersigned (in case of procuring materials for which the Royalty or Cess is required to be paid to the Govt. as per rule). The document /

proof in this regard shall be duly countersigned by the concerned agency.

26.Credential Certificate issued by the Pradhan has to be got countersigned by the Executive Assistant and Nirman Sahayak of the concerned Gram Panchayat.

27. All works will have to be done according to specification and drawing approved by the authority and as per direction of the

undersigned.

28. Deductions shall be made from the less value of the bill as per existing Govt. rules in form. The IT / GST / Construction Cess, etc. at source will be deducted as per Govt. Rule.

29. The intermediate payment by the Pradhan Kochdihi G.P., to the Contractor/ Supplier for the partly completed portion of the whole supply/ work is not mandatory. 31.If the contractor / Supplier desires an extension of time for completion of work / supply on the grounds of his having been unavoidably hindered in its execution, the contractor / Supplier shall produce an immediate report of such hindrance to the Pradhan, Kochdihi G.P., in writing and if he desires an extension of time for completion for work / Supply on the cessation of such hindrance, the Pradhan, Kochdihi G.P., may on reasonable grounds therefore authorize such extension of time, if in his opinion, it is necessary& proper. In event of incompletion of any work/supply within the stipulated time or the time extended, the G.P. office shall have right to impose compensation at the rate of one percent of the tendered value of work remaining unexecuted for each day of delay and/or to debar the contractor from the work/supply and/or the penalty may be imposed from the security deposit (including earnest money) at the rate as decided by under signed.

32. Ambiguous and conditional Tenders are not acceptable and will be out rightly rejected.

33. Subletting of works is not permissible and in that case earnest money of the contractor will be forfeited without assigning any reason thereof.

34. Any Tender paper not accompanied by the requisite earnest money or the other aforesaid supporting documents is liable to forthwith rejection.
