Necessary Earnest Money and cost of tender form shall have to be deposited by the intending tenderers by way of NEFT/RTGS in to the account number - 1158010124201, IFS Code – PUNB0115820 in favour of the Pradhan GOLGRAM Gram Panchayat, , Paschim Medinipur under PNB Bank. The proof of payment of Earnest Money and cost of tender form by way of NEFT /RTGS into the account mentioned here has to be documented for e-Tendering and virus free scanned copies of the same have to be uploaded in the website. The tenderer has to mention the NIT number and the SI No. of the scheme(s) he intends to partake during the tender process on the receipt of NEFT/RTGS and uploaded the same for all Scheme(s) for which he participates separately.
- Earnest Money will be @2.00% of the Tender amount and has to be deposited in the manner mentioned at Point 1.** Tender amount and value of tender form for all schemes may be deposited together. However, proper record of the same in the manner noted below has to be uploaded with each scheme for which payment has been made along with the receipt of NEFT/RTGS. It is the responsibility of the bidder to deposit the correct amount of Earnest Money and value of Tender Form for e-Tendering.
- Properly Indexed & self attested documents & duly digitally signed of both the Technical Bid and Financial Bid should be concurrently submitted in the website mentioned above as per time schedule given below.**
- Eligibility Criteria for participation in the Tender:**
 - The prospective tenderers as a primary agency, should have satisfactorily completed at least one work of similar nature for a magnitude of 50% of the amount put to the tender under the State Government or its undertaking or the Central Government or its undertaking during the last 03 (Three) financial years.
 - Technical Bid Documents should be accompanied with copies of tenderer's PAN Card, Professional Tax Receipt/ Challan for the current year, GST Registration Certificate.
 - Registered Co-Operative Societies of Unemployed Engineers and Diploma Holders in Engineering are required to furnish valid Bye-Laws. Latest Audit Report, Valid Clearance Certificate from Assistant Registrar of Co-Operative Societies for the last financial year along with other relevant supporting papers.
 - A Company shall furnish the Article of Association and Memorandum.
 - The partnership firm is requested to furnish the copy of Registered Partnership Deed.
- Payment of bill on its production will be made after successful execution of the work subject to availability of fund and no claim, whatsoever, will be entertained for any delay in payment. No escalation charge will be entertained against any e-NIT/ any accepted Tender. Deduction of Income Tax, G.S.T., Construction Workers' Welfare Cess, etc. will be made at source in accordance with the existing rules/ orders.
- Neither any Mobilization Advance nor any Secured Advance will be allowed.
- The Contractor shall have to arrange nearest to the work site, required land for installation of plant & machineries (specified for each awarded work), storing of materials, provision of labour shed & laboratory etc. at his own cost and responsibility.
