iii) Registered Partnership deed should be furnished (for partnership firm only) along with Power of Attorney to sign on the tender documents. (if required) and the company shall furnish the Article of Association and Memorandum. (to be documented through e-filing)

iv) **For Registered Labour Co-operative Society Ltd./Registered Engineers Co-operative Societies Ltd.** having Credentials (in the form of work completion certificate and payment certificates) from Engineer in Charge for similar nature of works done satisfactorily in any Government Department with actual date of completion & value of work which should
