The General Terms & Condition as follows:-

1. The intending Bidder have to apply for receiving "Tender Form & related Paper" to The Pradhan, Kenddangri Gram Panchayat, in their letter head pad with Sing & date including office Seal (if any) and supper scribed with i) NIT No & date, ii) Name of Scheme applied .
2. The undersigned reserves to right to accept or reject any or all application received without assigning any reason to any applicant.
3. Tender paper will be **available** at GP Office on 15/12/2025 TO 22/12/2025 within 11.30 A.M to 4.00 P.M (working day only) on non-refundable cash payment of fees as specified above as cost of tender paper.
4. Tender form will have to be **dropped** in sealed envelope in the earmarked box kept at the Gram Panchayat Office within 1.00 p.m. on 22/12/2025 Any offer will not be entertained after the above mentioned date and time.
5. The Tender will be **opened** on 24/12/2025 at 2 P.M in the GP Office. The attending tenderers or their Authorised representative may remain present at the time of opening tender.
6. If the last date of sub-mission & date of opening of tender as holyday, the tender will be received & opened on the next working day at the same time and venue.
7. **Earnest Money (Bid Security) and Security Deposit (Performance Security)**
 - 7.1. The intending bidder shall deposit the Earnest Money as specified in the tables above at Gram Panchayats Office only in form of **Cash** or **Demand Draft** drawn on Nationalized Bank or Scheduled Bank in favour of 'Pradhan, KenddangriGram Panchayat', or in Government Bonds or Securities duly pledged in favour of the Pradhan of Gram Panchayat **before submitting the tender**. The receipt number and date of such deposit shall be quoted on the tender paper submitted.
 - 7.2. No exemption in deposition of earnest money will be given for any Cooperative Society/Government owned Company/ Government Undertaking/Corporation/Engineering Co-operative etc. All participating bidders will be treated on equal basis. Any bid not accompanied by an acceptable bid security shall be rejected outright as non-responsive.
 - 7.3. The earnest money of unsuccessful bidders will be returned as promptly as possible, after issuance of Work Order to the successful bidder.
 - 7.4. The Earnest money of the successful tenderer shall be treated as part of security deposit and balance amount of security deposit to reach it to 10% of the total value of the work as quoted by him will be deducted from every running payment (not exceeding two including the final bill) made to the contractor on account of work done. The whole amount of security deposit will be retained for a period of six 6 months in case of civil structural works and 3 months in all other cases from the date of completion of the work.
8. **General Instruction to bidder for preparation and submlssion of tender papers**
 - 8.1. The Bidder should quote rates in **absolute numerical values** (both in figure & words), **not in percentage**. The quoted amount must be written or typed neatly. Corrections if any should be properly authenticated. Scheme wise separate comparative analysis will be made.
