The eligibility criteria are given below: -

1) Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover at least 3(three) years **100%** of the Estimated Amount put to Tender during **5(five) years** prior to the date of issue of this tender notice (both civil & electrical).

Audited Balance Sheet shall have to be produced in support of the turn over claim for the last 3 consecutive financial years.

Annual Turnover in contractual business should be authenticated by a Chartered Accountant.

2) Participants fulfilling the following eligibility criteria will be considered as technically qualified:

(I) Intending tenderers should produce credentials of a similar nature of work for each work of the minimum value of 40% of the estimated amount put to tender during 5(Five) years prior to the date of issue of this Tender Notice. This 5(Five) years will be counted from the date of completion of work for the work acclaimed as credential. Date of completion of the work must be mentioned in the credential certificate otherwise it will be rejected. Or as per finance rules of West Bengal govt.
