If any tenderer fails to produce the original hard copies of the documents like Completion Certificates and any other documents on demand of the "Tender Evaluation Committee" within a specified timeframe or if any deviation is detected in the hard copies from the uploaded soft copies, it may be treated as submission of the false document by the tenderer and action may be referred to the appropriate authority for prosecution as per relevant IT Act.

9. Rejection of Bid:

The employer reserves the right to accept or reject any bid and to cancel the bidding process and reject all bids at any period to the award of contract without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the ground for employers' action.


