1. In the event of e-filling, intending bidder may download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate.

Earnest Money Deposit and Cost of Tender Document Deposit of e-Procurement

Online receipt and refund of Earnest Money Deposit of e-Procurement through State Government eProcurement portal. The following procedure to be adopted for deposit of EMD/Bid Security/Tender Fees/Cost of Tender Documents related to e-Procurement.

A) Login By bidder :-

- a)A bidder desirous of taking part in a tender shall logging to the e-Procurement portal of the Government of West Bengal :- <https://wbtenders.gov.in> using his login ID and password.
- b)He will select the tender to bid and initiate payment of pre-defined EMD / Tender Fees / Cost of Tender Documents for that tender by selecting from either of the following payments modes :-
 - i) Net Banking (any of the Banks listed in the ICICI Bank Payment-gateway) in case of payment through ICICI Bank Payment Gateway.
 - ii) **RTGS/NEFT** in case of offline payment through bank account in any Bank.

B) Payment Procedure:-

i) Payment by NetBanking (any listed Bank) through ICICIBankPaymentGateway

- a) On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through he wants to do the transaction (As per order no. 2365-F(Y), Dated-12/04/2018 of Finance department , Audit branch, Govt. of west Bengal).
- b) Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
- c) Bidder will receive a confirmation message regarding success! failure of the transaction.
- d) If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling Account maintained with the Focal Point Branch for collection of EMD I Tender Fees I Cost of Tender Documents.
- e) If the transaction is failure the bidder will again try for payment by going back to the first step.

ii) Payment through RTGS / NEFT:-

- a) On selection of RTGS / NEFT as the payment mode, the e-Procurement portal **will show a pre-filled challan having the details to process RTGS/NEFT transaction.**
- b) The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account.
- c) Once payment is made, bidder will come back to the e-Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
- d) If verification is successful, the fund will get credited to the respective Pooling account of the maintained with the Focal Point Branch for collection of EMD /Tender Fees / Cost of Tender Documents.
- e) Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
- f) But if the payment verification is unsuccessful, the amount will be returned to the bidder's account,

C) Refund Settlement Process:-

- i) After opening of the bids and technical evaluation of the same by the tender inviting authority through electronic processing in the e-Procurement portal of the State Government, the tender inviting authority will declare the status of the bids as successful! unsuccessful which will be made available, along with the details of the unsuccessful bidders to ICICI bank by the e-Procurement portal through web services.
- ii) On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 bank: working days, where "T" will mean the date on which information on rejection of bid is uploaded to the eProcurement portal by the tender inviting authority.
- iii) Once the financial bid-evaluation is electronically processed in the e-procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through an automated process to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where "T" will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the tender inviting Authority. However, the L2 bidder should not be rejected till the LOI process is successful.
- iv) If the L1 bidder accepts the LOT and the same is processed electronically in the e-procurement portal, EMD of the L2 bidder will be refunded through an automated process, to his bank account from which he made the payment transaction. Such refund will take place within T+2 Bank working days where "T" will mean the date on which information on Award of Contract (AOC) to the L1 bidder is uploaded to the eProcurement portal by the tender inviting authority.
- v) All refunds will be made mandatorily to the any account from which the payment of EMD / Tender Fees I Cost of Tender Documents (if any) were initiated.

- 2. Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <http://wbtenders.gov.in>
- 3. Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated in Sl. No. 15
- 4. The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL BID** of the tenderer is found qualified by the 'Tender Evaluation Committee' formed by the **"The Prodhan, GOBINDAPUR Gram Panchayat"** The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.
- 5. **Eligibility criteria for participation in the tender.**
 - o Resourceful, bonafide & Experienced contractors having **at least 60%/50%/40% credential certificate & (credential certificate for last 3 Financial year)** of work of Similar Nature of work) and valid & up to date IT, and Professional Tax clearance.
 - o **Income Tax Acknowledgement Receipt** for the latest Three Assessment year, P.T. Enrollment & Challan for the Latest year, Pan Card, GST Registration Certificate with current return are to be accompanied with the Technical Bid Documents.
 - o The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 3 (*Three*) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A

declaration in this respect through affidavit has to be furnished by the prospective bidders without which the Technical Bid shall be treated as non-responsive.)

- The prospective bidders should own or arrange through lease hold registered agreement, the required plant and machineries. Conclusive proof of ownership in favour of owner or leaser of plant and machineries in working condition shall have to be submitted.
 - Registered Partnership Deed for Partnership Firm only along with Power of Attorney is to be submitted. The company shall furnish the Article of Association and Memorandum.
 - Registered Labour Co-operative Societies are required to furnish valid Bye Law, Current Audit Report, Minutes of last A.G.M. , valid certificate from A.R.C.S. along with other relevant supporting papers.
 - **Joint Ventures will not be allowed.**
 - A prospective bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applications will be rejected for that job, without assigning any reason thereof.
6. Running payment for work may be made to the executing agency as per availability of fund. The executing agency may not get a running payment unless the gross amount of running bill is 25 lakh or 30% of the tendered amount.
 7. Escalation of prices in respect of construction materials shall not be considered.
 8. No mobilisation advance and secured advance will be allowed.
 9. Security Deposit:
Retention money towards performance Security amounting to 10% (*ten percent*) of the value of the work shall be deducted from the running account bill of the tenderer as per prevailing order. No interest will be paid on Security Deposit.
 10. Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.
 11. All materials required for the proposed work including cement and steel shall be of specified grade and approved brand in conformity with relevant code of practice (latest revision) and manufactured accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Authenticated evidence for purchase of cement and steel are to be submitted along with challan and test certificate. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.
 12. Constructional Labour Welfare CESS @ 1% (*one percent*) of cost of construction will be deducted from every Bill of the selected agency
- 13. There shall be no provision of Arbitration.**
14. Bid shall remain valid up to 90 days from the date of opening of Financial Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
 15. The Agency shall quote their rate in percentage basis i.e. Above /Less/At par (Both in figures as well as in words) in the given space of Financial Bid Documents only...
 - **[MEMORANDUM:-Additional Performance Security when the bid rate is 80% or less of the Estimate put to tender and no increase in scope of work of projects during execution phase.(As per order no. 4608-F(Y), Dated-18th July, 2018 of Finance department , Audit branch, Govt. of west Bengal).]**
- ❖ In tenders for Government works, bids are sometimes receive data much lower rate than the Estimated Amount put to tender. In such cases, to ensure the quality and proper execution of the work in public interest, the Governor is pleased to decide that Additional Performance Security @10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the Estimate put to tender.
 - ❖ The Additional Performance Security shall be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his Earnest Money will be forfeited and other necessary actions as per NIT like black listing of the contractor, etc, may be taken. The Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required.
 - ❖ The Bank Guarantee shall be returned immediately on successful completion of the Contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding deduction of security deposit from the progressive bills of the contractor as per relevant clauses of the contract shall in no way be altered/affected by provision of this Additional Performance Security.
 - ❖ Henceforth, necessary provision shall be incorporated in all Notice Inviting Tenders and shall be part of the Contract Agreement.
 - ❖ **This order will take immediate effect and necessary amendment in the West Bengal Financial Rules shall be made in due course.**

18. The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of **6 Month** from the date of successful completion of the work to the entire satisfaction of the Exetuve Officer. If any defect / damage is found during the period as mentioned above,thecontractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect.
- Refund of Security Deposit** will only be made after successful maintaining of appropriate service level of the work as mentioned above for 6 (six) months from the date of completion of the work.
19. Site of work and necessary drawings may be handed over to the agency phase wise. No claim in this regards will be entertained.
20. 21. The intending Bidders shall clearly understand that whatever may be the out come of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The **"The Prodhan,GOBINDAPUR Gram Panchayat"** reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.
- 22. Conditional / Incomplete tender will not be accepted under any circumstances.**
- 23. The intending tenderers are required to quote the rate online.**
24. Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating there to and the rules made and order issued there under from time to time.
- a) LabourLicence mandatory for e-filling against this tender.
25. Guiding Schedule of Rates: Rates have been taken from P.W.D. (W.B.) Schedule of Rates for "Building Works Materials Labour" wef01.11.2017&"ROAD & BRIDGE WORKS"wef 30.08.2018.
26. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect/ manufactured/ fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice, and EMD will be forfeited.
27. The **"The Prodhan,GOBINDAPURGram Panchayat"** reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
28. Before issuance of the WORK ORDER, the tender inviting authority may verify the credential and other documents of the lowest tenderer if found necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.
29. Qualification criteria:
- o The tender inviting and Accepting Authority through a "Tender Evaluation Committee" will determine the eligibility of each bidder. The bidders shall have to meet all the minimum criteria regarding:
 - i. Financial Capacity
 - ii. Technical Capability comprising of personnel & equipment capability
 - iii. Experience / Credential



1. Rate should be quoted in percentage (in ward in figures).
2. The rate as specified in the price schedule including the cost of quarrying, loading, unloading, carrying, stacking in site, royalty and other taxes etc. complete.
3. No extra payment will be made for carrying of materials involving head load / trolley etc.
4. Work must be completed within schedule time.
5. Earnest money @2% of the Estimated value is to be deposited in the form of Net Banking & NEFT/RTGS and must be enclosed with the tender documents.
6. If the accepted tenderer fails to execute on agreement within the date mention in the letter of intimation, his name should be brought into book for taking disciplinary action and his earnest money will stand forfeited.
7. Security money @ 10% of the value of work done by the concerned contractor/ agency will be deducted from each R.A bill / Final bill.
8.
