1 Separate Sealed Tenders in Printed form at Daldali Gram Panchayat are hereby invited by the Pradhan, Daldali Gram Panchayat for the following Civil works mentioned in the Annexure 1

1 The intending tenders will have to satisfy the Pradhan, Daldali Gram Panchayat, with documents as evidence by producing their past experience to do such type of work i.e satisfactory completion certificate, payment certificate, credential certificate for similar type of work covering more than 60% of the value of the work applied for. Details of works to be done with Plan, Specification, additional terms and condition etc. may be seen in the office of the undersigned, in any working days between 11.00 hrs to 15.00 hrs.

2 Tender documents will be issued on submission of written application accompanied by the original and Xerox copies of the following valid documents duly attested, failing to submit any one of such documents application may not be entertained. Original documents shall be returned to the tenderers just after scrutiny of the Xerox copies submitted by them. Attested Xerox copy will not be returned in any circumstances.

3 Tender which should be always in sealed cover with the name of work, NIT No must written on the envelop will be dropped in the Tender drop box in The Office of the Pradhan, Daldali Gram Panchayat. Up to specified date and time shown in annexure

4 Agencies desire to participate in the tender are requested to apply for tender form etc. in plain paper enclosing attested copies of the following documents as directed

- A) Trade License With updated
- B) Permanent Account No. (PAN) With updated Income Tax Clearance Certificate.
- C) Professional Tax Registration certificate with Updated Clearance Certificate
- D) G.S.T. Registration Certificate With Updated Clearance certificate
- E) Credential Certificate of similar type of work covering more than 60% of the work value as mentioned in annexure against the eligibility criteria for the year
2019-20 2020-21 2021-22 & 2022-23 2023-24

F) In case of partnership firm, attested Xerox copy of Partnership Deed and current audit report must be submitted with the documents.

G) In case of Companies or firm, attested Xerox copy of registered ownership and current audit report must be submitted with the documents.

H) In case of registered co-operative societies, attested Xerox copy of registration certificate and current audit report must be submitted with the documents.

5 Earnest Money @2.00% / 2.50% to be deposited in the form of DCR or Demand Draft from in any nationalized bank with the Tender which is shown in Annexure and shall be in favour of the Pradhan, Daldali Gram Panchayat, Vill+P.O:- Daldali, P.S:- Hura, Dist:- Purulia and Payable at State Bank of India. Hura Branch. (Except State Bank of India. Hura Branch)

6 N.S.C/K.V.P./Bankers Cheque will not be entertained.

7 Tender will be opened by the Pradhan, Daldali Gram Panchayat, at her chamber in presence of the intending tenderers / Their authorized representative (s). If the date of opening of the Tender be declared as holiday or office remain closed due to administrative reason or any other reason, what so ever, the Tender will be opened on the next working day at the same time. Other condition will remain same.

8 Separate sealed covered must be used for each Tender. Rate should be quoted in figure and words. Scheduled of rate attached to the Tender Form in the space provided. The Tendered which contains over writing of any manipulation are liable to be rejected. All corrections should be attested under the dated signature of the tenderers.

9 Issue of tender form/The acceptance of tender will be rest with Pradhan, Daldali Gram Panchayat, who does not bound herself to issues tender form/ accept the lowest Tender or any tender and reserves the right to herself if the right to reject any of the Tender receipt or all without assigning any reason thereof. In this context, the description of Pradhan, Daldali Gram Panchayat, will be final binding upon the applicant for tender form/ tenderers.

However anybody not satisfied with the decision of the Pradhan, Daldali Gram Panchayat, is free to appeal to the appropriate authority also reserves the right to offer any serial of work in the annexure other than the specifically prayed for by the applicant and to distribute a particular work amongst more than one contractors without assigning any reason.

10 Successful bidder must be execute a contract on Stamp paper amounting of Rs.10.00 (Rupees Ten only) prior to issuance of Supply/Work order by the Pradhan, Daldali Gram Panchayat. The terms of contract including accepted bid value duration (start and end date) penalty provision quality of work payment terms etc. if the bidder fails to execute the contract within the time stipulated by the Gram Panchayat the bid will be liable to be cancelled. The power-of-attorney, which may be characterized, as agency agreement will not be accepted without specific order of the Government

11 Successful bidder whose tender is accepted will be required to furnish security deposit for due fulfilment of his contract amounting 10%(Ten Percent) of the total value of work actually done. The earnest money shall be converted as a part of the security money and balance shall be realised by deduction from each progressive bill. So that the total deduction together with the earnest money already taken constitutes 10% of the total value of the work actually done.

SPECIAL TERMS AND CONDITION:-

- 1) Before supply of materials the sample should be approved by the Pradhan, Daldali Gram Panchayat.
- 2) I.T., G.S.T. and Education cess & Labour Cess will be deducted from the bill as per Govt. Noms.
- 3) Suppliers should quote their rate including Carriage, Loading, Unloading and Stacking and all other charges at Delivery point.
- 4) Supply Quantity should be order time to time as per requirement through out the financial year.
- 5) Rate will be valid upto complete of the work for any quantity of items as per annexure and the right of extension, Termination Vest on the Gram Panchayat.
- 6) Payment will be made as per availability of fund. No Claim for delay of payment due to non availability of fund will be entertained. At the time of payment of each bill deduction will be made for Income Tax, G.S.T., LWC as per present Govt. norms of Govt. of West Bengal.
