The pre-qualification documents alone will be opened for Technical Bid evaluation and selection of qualified bidder on **6TH JUNE, 2025 at 15:00 Hours** by the Pradhan , Amdabad-II Gram Panchayat .

The financial bid documents of the technically qualified bidders when will be Technical Bid open. If the office happens to be closed on the date & time for opening of tender as specified in NIT the date will be on the next working day at the same time & venue unless and otherwise announced anything. No individual intimation will be given. Amdabad-II Gram Panchayat Authority reserves the right to reject or cancel any or all prequalification documents and bid document without assigning any reason whatsoever.

Annexure-B

THE ELIGIBILITY CRITERIA ARE GIVEN BELOW: -

1. The applicant in the same name and style as prime contractor should have successful completed at least one contract of **similar type** of Civil Engineering work upto 5 lakhs to a value of 60% and 5lakhs to 10 lakhs to a value of 50% and above 10 lakhs to a value of 40% of estimated cost in a single tender completed within last **5 Financial year** (including current financial year) from the Govt. / Semi Govt. Organizations.
2. The contractor should have sufficient technical manpower, tools and plants to complete the work.
3. **GST**, GSTR-3B, I.T. (PAN, Trade Certificate, and I.T. Return submitted for the last 3 (three) financial year); **GST registration certificate** & GSTR-3B; and P.T. clearance certificate up to date and **Bank Account Details**.
4. All duties, taxes, royalties, cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**
5. The intending bidders are requested to inspect the site of the proposed construction before quoting their bid.
- 6..Cost of Tender Form (non-refundable) has to be paid in Bank Account only.
7. Joint Vender Not be Allow.
8. Bidders must submit attested photocopies of valid GST registration Certificate and GSTR-3B Last Return(if any), last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
9. Bidders must submit Credential in similar nature of work during last three years.
10. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
11. Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
12. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
13. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
14. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
15. Earnest money should be deposited through Banker's Cheque/Demand Draft/NEFT/RTGS in favour of "**The Pradhan, Amdabad-II Gram Panchayat (Account No -5191011002648)**" and payable at **Gholpukuria Branch of Nandigram of Purba Medinipur District and refunded through Bank account**.
16. Successful Bidder (s) will be required to lodge security deposit 10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Amdabad II Gram Panchayat or the amount may be deducted from every running payment (not exceeding three including the in al bill) made and will be released 6 months in case of

Building, Culvert and Concrete Roads and 3 months in all other cases.

17. TDS on GST, GSTR-3B ,ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the government.

18. Pre-bid conference/meeting with the prospective Bidders will be held on 31/05/2025 at 2.00 pm (not later than 4 days before the last date of submission of eTender). Environmental and Social Safeguards issues pertaining to the tendered work will also be discussed and explained in the meeting.

19. Site visit may be done by the bidders at their own cost.

20. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.

21. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

22. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Amdabad II Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.

23. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.

24. Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc.

25. Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.

26. Bidders will get necessary drawings with the Tender Form. All documents i.e. drawings Tender Form signed by the Bidder must be submitted in e Tender addressed website <https://wbtenders.gov.in/reports>.


