- 1. No separate intimation will be given unless the above dates are changed. In case of change of dates, due intimation will be given online only. No individual intimation will be given.
- 2. The undersigned reserves to right to accept or reject any or all application received without assigning any reason to any applicant.
- 3. The attending tenderers or their representative may remain present at the time of opening tender.
- 4. If the last date of submission and date of opening of tender fall as holiday, the tender will be received and opened on the next working day at the time and venue.
- 5. Cost of Tender Document and Earnest Money will be deposited a) Net Banking (any of Banks listed in The ICICI Bank Payment gateway) in case of Payment through ICICI Bank Gateway. Or b) in------in favor ------IFSC No-----through of RTGS/NEFT/CBS system Only) The Package number should be clearly mentioned of the Chillan. Payment made otherwise will be rejected.
- 6. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Co-operative Society/Government owned Company/ Government Undertaking / Corporation / Engineering Co-operative etc. In other words all participating bidders will be treated on equal basis only and no favourable / special considerations will be accorded to any bidders.
