IN CASE OF OTHERS WORKS

- 15 In case of Ascertaining Authority at any stage of application or execution of work necessary registered power of Attorney is to be produced.
- 16 NO CONDITIONAL/ INCOMPLETE TENDER will be accepted under any circumstances.
- 17 The undersigned reserves the right to cancel the N.I.T. due to unavoidable Circumstances and no claim in this respect will be entertained.
- During tender processing or when the work in progress, if it comes to the notice to Tender Inviting Authority that the credential or any other papers found incorrect/manufactured/fabricated, that tender will be rejected without any prejudice and necessary action will be taken as per law.
- 19 Before issuance of the work order, the Tender Inviting Authority may verify the credential & other documents of the lowest tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer is either manufacturer or false in that case, work order will not be issued in favour of the tenderer under any circumstances & E M D will stand forfeited at any stage without any reference to the bidder.

1 General guidance for e-Tendering

2 Registration of Contractor

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System; through logging on to https://wbtenders.gov.in the contractor is to click on the link for e-Tendering site as given on the web portal.

#### Jigital-Token

Each contractor is required to obtain an e-Token for submission of tenders, from the approved service provider of the National Information's Centre(NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2 of Guideline to Tenderer as a USB e-Token

The contractor can search & download Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the e-Token. This is the only mode of collection of Tender Documents.

### Participation in more than one work.

A prospective bidder (including his participation in partnership) shall be allowed to participate in mentioned in the list of schemes. In no case permission will be accorded to any Firm for more than 1 (One) job.
