Eligibility of Contractor:

- i) Intending tenderer should produce credential with work order of **similar nature*** of completed work for the minimum value for at least **60%** of amount put to tender within last **3 years i.e. 2022-23, 2023-24 & 2024-2025 in a single work**. Credential with work order from any Govt. /Semi Govt. and from autonomous bodies as prime contractor will be entertained for schemes having completion certificate as proof of credential. Payment Certificate will not be allowed.

1. Rejection of tender:

The employer (tender accepting authority) reserves the right to accept or reject any Tender and cancelled the Tendering processes and reject all Tenders at any time prior to the award of Contract without thereby incurring any liability to the affect Tenderer or Tenderers or any obligation to inform the affected Tenderer or Tenderers of the ground for Employer's (tender accepting authority) action.

The FINANCIAL OFFER of the prospective tenderer will be considered only if the TECHNICAL BID of the tenderer is found qualified by the 'Tender Evaluation Committee' of Salda Gram Panchayat, Joypar, Bankura. The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.

During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect / manufactured / fabricated, that tender will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forth with.

2. Penalty for suppression / distortion of facts:

Submission of false documents by tenderer is strictly prohibited and in case of such act by the tenderer the same may be referred to the appropriate authority for prosecution as per relevant IT Act forfeiture of earnest money.

3. The intending tenders if found himself eligible to participate in the tender, should download the details tender notice along with tender documents from wbttenders.gov.in the cost of tender documents and the Earnest Money Deposit(EMD) as specified should be deposited in the form of either **NEFT/RTGS Form** will be generated from their (bidders) own Digital Signature Certificate or through **Net Banking System** by the way of **ICICI bank payment Gateway**. The tenderers will have to submit their bid online. In two cover / folder system containing pre-qualification documents (technical bid) in one and financial bid in another. The documents submitted by the bidder should be properly indexed and digital signed.

4. Eligibility criteria for participating e-tender :

Copy of valid PAN Card issued by the IT Department, Govt. of India, Income Tax acknowledgement receipt for latest 3 (three) assessment year (2022-23 ,2023-24 & 2024-2025), Professional Tax clearance certificate with P.T. (Challan) (from 01.04.2024 to 31.03.2025) and valid 15-digit Goods and Services Tax to be accompanied with the Technical Bid Documents., Valid Trade License (from 01.04.2024 to 31.03.2025).

5) Registered Partner Ship Deed in case of partnership firm has to be submitted. The Company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for on behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of such company or the partners of such firm to upload such tender. **(Non-Statutory Documents)**

6) **Joint venture will not be allowed.**

7) The tenderer shall established field testing laboratory equipped with requisite instrument and technical staffs according to the requirements of works to be executed.

8) Payment will be made as a when fund is available from the concern source. No claim whatsoever for delayed payment, if any will be entertained. Total 3 (three) nos. bill (including final bill) will be paid for this work. Contractors are requested to quote their rate accordingly.

9) No arbitration is allowed in this contract.

10) **10 (ten) %** value of the work will be retained as security deposit which will be released after 6 (Six) Months from successful completion project. Agencies have to arrange land for direction of Plant & Machineries, storing of materials labour shed, Lab rotary etc. water and electricity at their won cost and responsibility.

11) No material will be issued from the department.

12) Constractional labour welfare cess at @1% of the bill value will be deducted from every bill.

13) Contractors shall have to comply with the provisions of A) the contract labour (regulation Abolition) Act, 1917 B) apprentice Act 1961 & C) Minimum wages Act, 1948 of the notification there of or any laws relating there to and the rules made and order issued there under from time to time.

14) The schedule of rates as given in BOQ.

15) During scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/manufacture/fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

16) The authority reserves the right to cancel the NIT due to unavoidable circumstance and for this no claim will be entertained.

17) Bids shall remain valid for a period not less than 30(thirty) days from the last date of submission of Financial Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

18. Before submission of tender, the tenderer shall have to acquaint by actual visit to the site as regards prevailing conditions and tenderer submitting tender shall be deemed to have done so. He must acquaint himself with local conditions of labour, material, transport, electricity, water, Panchayat regulations etc.

19. It will be contractor's responsibility to keep the road open to all kind of traffic during the execution of work. No Claim what-so-ever will be entertained for idle labour, establishment cost of hire & labour charges of tools & plants etc. at any circumstances.

20. The contractor shall pay of charges & fees legally payable for act out of their works & hold the employer free of such cost.

21. Contractor has to execute the work on strict supervision of the beneficiary committee & Gram Panchayat Engineer / Authorities.

22. Decision of Selda Gram Panchayat authority will be final & binding on contractor in case of any dispute.
