- 3/ Rate offered by a Bidder in a particular Tender shall be treated as final and subsequent negotiation with that Bidder for change in price shall not be allowed
- 4/ multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- 5/ No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favorable/special considerations will be accorded to any bidders.
- 6/ Earnest Money/Bid Security: Cost of Bid Security/Earnest Money should be deposited through RTGS/NEFT, payable to Pradhan, Kaliachak-II Gram Panchayat, Kaliachak, Malda.
