The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least 50% value of the proposed contract within the last 5 years.

Original of IT Return (Assessment year 2021-2022 onwards), P.T Enrollment certificate along with PT challan (current year), GST Registration Certificate must be submitted xerox copy with self attested. For registered Engineers Co-Operative Society & Registered labour Co-Operative Society including submission of Bye-Laws, valid audit report for the last three (3) years, valid ARCS certificates and other papers & submit the same with full address of their and authorized person to sign on tender documents along with Technical Bid papers. During scrutiny of Technical Bid / Tender documents if it is found that any information is incorrect the Technical Bid / Tender documents will be rejected without assigning any reason thereof. The Prodhān, Kodalia-II Gram Panchayet will have sole discretion to decide the eligibility of the Contractors on the basis of his submitted documents and evaluation thereof and reserve the right to refuse with out any explanation to the Contractor and to refuse issuance of tender to any applicant without assigning any reason thereof and the decision of the Prodhān, Kodalia-II Gram Panchayet in this respect will be final. A site Order Book with triplicate pages must be kept at the site office of the agency for the work and day to day instruction, whenever required, will be recorded by the Nirman Sahayak of the Kodalia-II Gram Panchayet Office in connection with the work.

8. (a) * Completion certificates issued by competent authority will normally be considered as credentials apart from credentials of work executed under Irrigation & Waterways Department, Credentials of works executed under Public Works Department & Public Works (Roads) Department, Public Health Engineering Departments, Sundarban affairs Department & other state Government Departments, Development Block, WBHIDCO, WBSEDCL, KMDA, KMW, & SA, KMC, HRBC, Engineering Departments of Central Government Department & Organizations like Railways, KoPT and Mackintosh Burn Ltd. Westinghouse Saxby Farmer Ltd. & Britania Engineering Ltd./other Gram Panchayet's may also be considered. Completion certificates are to be countersigned by the Executive / Divisional Engineers of the respective State / Central Government Departments, or Officer of the equivalent rank, if those are issued by some other authority. Over and above the completion certificates, certificate from the competent authority regarding payment received so far for the work (even if the full payment might not have been received), supported by Bank Statement showing that the corresponding amount of payment has actually been deposited in the Bank, will have to be produced in the cases of works executed under Departmental / Organizations other than Irrigation & Waterways Department, failing which credentials may not be considered."

Additional Terms & Conditions

1. Time is the essence of contract. The successful contractor must complete the work within the time specification for completion. No extension of time will be allowed except in special case. If any contractor fails to supply the materials for the work within the stipulated time the work order issued in his favor will be cancelled without assigning any reason therefore. The undersigned may also proceed to get the balance work completed by any other means including through other contractor. The excess expenditure, if any, due to such a step would be recoverable from

2. Earnest money noted against the name of work @ 2% of the value of work will have to be deposited through Cost of Tender documents & Earnest money fees is to be deposited through NEFT ICICI BANK online e-procurement system. The earnest money will be converted into security money after acceptance. Balance 8% security money will be deducted as per norms.

3. GST will be deducted as per notification, memo no. 5050-F(Y) dated- 16.08.2017 of Govt. of West Bengal Finance Department audit branch.

4. Incomplete tender(s) will be rejected summarily. The successful tenderer will have to execute a formal agreement on a Non-judicial Stamp worth Rs. 10/- (Rupees ten only) & receive the 5. All works will have to be done according to specification and drawing approved by the authority and as per direction of the Prodhān, Kodalia-II Gram Panchayet.

6. No consumable materials will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for procuring all materials required for proper execution of work at its own cost.

14. Before submission of the tender the contractor must visit the work site to judge the Local condition from all corners and no plea/complain about the site will be entertained afterwards. It will be presumed that the agency offered the tender after reviewing entire position the worksite.

15. All working Tools and plants and implements required for the work are to be arranged and supplied by the successful tenderer at his own cost.

16. The successful tenderer will have to abide by the provisions of West Bengal Contractor Labour (Regulation and abolition) Rules, 1972 as well be force from time to time. If no labour be claimed for idle labour from contractor will not be entertained under any circumstances. No claim will be entertained for any increase in railway freight and market price.

18. Credential: Not less than 50% of the tendered amount (for value of works above Rs.5,00,000/- upto 10,00,000/-) of this notice on a SAME /SIMILAR and SINGLE construction work shall only be accepted. Credential acquired within the last 5(five) financial years shall only be accepted. Credential issued by authority not below the rank of Gram Panchayet/ Block/Panchayat Samity/Municipality and other Government department only shall be accepted. The credential certificate in the form of work completion on Payment Certificate only should clearly mention the NIT No. & date, Work Order No. & date, Name of work (complete), net amount, gross amount and deduction and cost of departmental supply (if any). Credential of supply may be accepted. Credential found defective or incomplete in any way shall summarily be rejected.
