**General Terms & Conditions:-**

1. The quoted rates shall be inclusive of GST, Labour Cess and all other charges like carriage, loading & unloading, royalty, toll, all duties, taxes and other levies. No additional claim will be entertained.
2. The tenderer shall examine the various provisions of the CGST Act and Rules (up-to-date amendments) and other applicable taxes before bidding.
3. Tax invoice(s) needs to be issued by the supplier/Contractor for raising a claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017. The taxes will be calculated as per the rules.
4. Bidder will select the tender to bid and initiate payment of pre-defined EMD and Tender Fees for that tender by selecting from either of the following payment modes:
  - i) ICICI Bank: Net banking in case of payment through ICICI Bank Payment Gateway;
  - ii) ICICI RTGS/NEFT: The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his own Bank account
