The Technical Bid (Statutory & Non Statutory Cover) and Financial Bid both will be submitted concurrently duly digitally signed in the website: <http://wbttenders.gov.in>

(b). The scanned copy of NEFT/RTGS, Bank Challan for both cost of Participation Fee and EMD must be uploaded with technical bid, otherwise bid will be clearly rejected. Both the cases the Contractor/Agency's name NIT No. & Sl No. of work to be mentioned clearly on the RTGS/NEFT form and the said RTGS/NEFT form should be scanned and uploaded in e-Filling folder.

4. Eligibility criteria for participation in tender:

The Application must be accompanied with the following documents.

a) Bonafied resourceful Contractor / Outsider who have Satisfactorily completed as a prime agency during the last 5(five) years from the date of issue of this N.I.T at least one work of similar nature under authority of State/Central Government, State/Central Government undertaking, Statutory Bodies Constituted under the statute of the Central/State Government at least in the magnitude of 60% (Sixty percent) of the amount put to tender.

N.B:- Estimated amount, date & period of completion of project and details communicational Address of the client must be indicated in the Credential Certificate.

b) (i) PAN Card, (ii) WITH LAST 3(THREE) YEARS INCOME TAX RETURN & AUDIT REPORT, (iii) TRADE REGISTRATION CERTIFICATE /LISENCE FROM LOCAL BODY, (iv) Valid GST Registration Certificate with up to date Challan & (v) PROFESSIONAL TAX REGISTRATION CERTIFICATE WITH CURRENT CHALLAN/ acknowledgement receipt.

c) Registered Partnership Deed (for Partnership Firm only) along with Power of Attorney to sign on the Tender documents (if required).

d) Declaration regarding Structure and Organization duly signed by the applicant.

e) Registered Labour Co - Operative Societies Ltd. are required to furnish valid Bye Law, Current Audit Report, along with other relevant supporting papers. Joint Ventures will not be allowed.

The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.

5. Please read as Matikunda-I Gram Panchayat, Islampur Panchayat Samiti, Uttar Dinajpur in place of Divisional/Sub-Divisional officer as may be found in the Contract Document.
