The Application must be accompanied with the following documents.-

(a) Bonafide agencies having credential of 60% (Sixty percent) of the estimated amount put to Tender for works of similar nature and not older than 3(Three) years from the date of calling NIT. Credential Certificate should be issued by the person not below the rank of Nirman Sahayak of Gram Panchayet mentioning **Actual Date of Completion**. Credential Certificate content **Work Order, Payment Certificate, Completion Certificate, bill value, NIT no & Date**.

(b) Income Tax return with (Last three years) duly received along with PAN Card, GST Registration Certificate & P.T. acknowledgement receipt for the year 2025-26.

(c) Trade Registration Certificate for FY - 2024-25. Registered Partnership Deed (for Partnership Firm only) along with Power of Attorney to sign on the Tender documents (if required).

4. Constructional Labour Welfare CESS @ 1(one) % of cost of construction will be deducted from every Bill of the selected agency, GST, Royalty & all other Statutory leavy / Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & cess stated above.

5. Bid shall remain valid for a period of 30 (thirty) days after the dead line date for Financial Bid / Sealed Bid submission. Bid valid for a shorter period shall be rejected by 'Tender Inviting Authority' as non-responsive.

9. Necessary tax will be deducted from each bill as per Government norms.


10. No part payment will be given to the agency. The payment will be made after successful completion of the work.

After verification, if it is found that such documents submitted by the lowest tenderer is either manufactured or false in that case, work order will not be issued in favour of the tenderer under any circumstance.
