The Sealed Tenders will be opened on the same day, i.e. on 17/04/2025 at 2 P.M. in presence of all bidders, who may wish to remain present. Annexure-B

Terms & Conditions:-

- Cost of Tender Form (non-refundable) is to be paid on the spot.
- Bidders must submit latest photograph of the bidder, registration certificate, PAN card, last three years income Tax Return, Profession Tax Registration Certificate, with the current challan and Trade Registration Certificate/License from local bodies as the case may be.
- Bidders must submit: Credit in the name of work during last three years. You have to mention 60% credit for implementing schemes.
- In case of withdrawal of tender, the tenderer's name will be cancelled.
- Bidders must quote in the tender document the values (both in figures and words) against the estimate cost. Rate quoted in percentage form will be rejected.
- Rate offered by bidder in particular Tender shall be treated as final and subsequent negotiation with the bidder for change in prices shall not be allowed.
- Multiple bid or rejection of one bid by same bidder and/or submission of different rates of same item by same bidder shall be rejected outright.
- No special preference in respect of Earnest Money, Security Deposit will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/Engineering Cooperative Societies. In other words, all participating Bidders will be treated on equal basis on the basis of Government Bond/Security Deposit. Bidders will be considered on equal basis (Applicable only for ISGP Block Grant). Enlisted contractors may apply without Earnest Money.
- Bidders must submit sealed envelope clearly mentioning the number and name of work on top of the envelope.
- Earnest money should be deposited in Cash/Bank Draft or Government Bond/Security Deposit in favour of the Pradhan, Birsingha Gram Panchayat and will be refunded/forfeited on the basis of the following: In case of Cash/Bank Draft, the bidder must collect receipt from the Gram Panchayat office and quote it in the Tender Form. In case of Government Bond/Security Deposit, the bidder must submit the relevant documents with Sealed Tender.
- Successful Bidders will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Bank Draft/Government Bond/Security Deposit in favour of the Pradhan, Birsingha Gram Panchayat. The same will be deducted from every running payment (not
