No exempted category will be allowed for EMD and Tender Fees.

The pre-qualification documents alone will be opened for evaluation and selection of qualified bidder on 26th day of July'2024 at 13:00 hours by the Executive Officer, Bhagwanpur-I Panchayat Samity. Name of the qualified bidders will be uploaded in the above mentioned Website.

The opening of financial bid documents of the technically qualified bidders will be notified on the day of technical evaluation. No separate intimation will be given for this, unless the above date is changed. If the office happens to be closed on the date & time for opening of tender as specified in NIT the date will be on the next working day at the same time & venue unless and otherwise announced anything. No individual intimation will be given.

Authority reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

THE ELIGIBILITY CRITERIA ARE GIVEN BELOW:-

1. All intending bidders are bound to adhere to the clause set forth in this document for bidding in the tender process. By participating in the bid it will be assumed that they have read, understood and agreed to the entire clause set forth in this Notification.
2. **Credential Certificate** must be submitted at least one contract of similar nature of works to a value of 40% of Tender cost in a single tender completed within last 5 years (prior to the date of issue of the tender notice), from the Govt. / Semi Govt. Organizations.
3. The contractor should have sufficient technical manpower, tools and plants to complete the work. Sub contracting to any other agency is not allowed.
4. Sale Tax, PAN, I.T. Return submitted for AY 2021-22, 2022-23 and 2023-24 . GST registration certificate with return minimum the month of April'2024. And P.T. clearance up to date. The P.TAX (eChallan) submitted upto 31.03.2025.
5. All duties, taxes, royalties, GST, Cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**
6. Trade License issued from any Govt./ Semi Govt. organizations for the current Financial Year.
