(b) PAN Card, & I.T. Returns of three Assessment Years of 2022-23, 2023-24, 2024-25 ( i.e. F.Y. - 2021-22 , 2022-23 , 2023-24, ) , GST Registration Certificate or last GST Return Certificate,Profession Tax Registration Certificate with current challan AND Trade Registration Certificate/License from local bodies (as the case may be)has to be accompanied with the technical bid document (Non- Statutory Documents).
