- 1) Last date & time of issue form QUOTATION form:10.04.2025 (01..30pm)
- 2) Date & time of and Dropping and Opening of QUOTATION form :-13.04.2025 (1.00 pm)
- 3) Attested photocopies of certificates(either self or attested by authorized person)
- 4) PAN with Last three Assesment years Income tax return(2022-23,2023-24,2024-25)
- 5) GST registration certificate & upto date return(Last quarter or Last Month).
- 6) Professional tax Challan & Certificate(2025-26)
- 7) Trade certificate (2025-26),
- 8) Credential for last three years(2022-23,23-24,2025-26)
- 10)The QUOTATION paper & QUOTATION documents (including Earnest money details) should be submitted separately in sealed envelope in two separate specified boxes (One containing Technical Papers & other containing Financial bid)to the undersigned during office hours up to 12 noon on 13.04.2025 Original of documents will have to be produced at the time of Verification. During verification of QUOTATION documents if it is found that all the relevant paper was not submitted or the documents submitted is not fulfill the terms & condition of QUOTATION notice will be treated as cancel & his/her QUOTATION paper will not opened thereon..
- 11) Security deposit of 10% .will be deducted from the progressive bills and would be refunded only after expiry of the defect liability period and satisfactory condition of the work.
- 12) Earnest money noted against work shall have to be deposited in bank draft/bankers cheque only .
- 13) Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- 14) Necessary taxes as per current Govt. rules would be deducted from the running bills of the contractor.
- 15) Shrinkage of the material would be deducted from the stack measurement at site. Any sub standard material supplied at site would have to be replaced within 3 days from the date of receipt of such intimation at his own cost.
- 16) All Quotaioner must be serious about the completion of work,if delayed his/her quotaion will cancelled without assigning any reason & earnest money will be forfeit. The undersigned may also proceed to get the balance work completed by any other means including through other Agency. The excess expenditure, if any due to such a step would be recoverable from the unpaid bills/ earnest money deposit / security deposit of the Quotaioner.
- 17) No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders .
- 18) Erroneous or incomplete Quotaion Form will be summarily rejected without assigning any reason whatsoever.

Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either too high or low than estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

0) Successful Bidder will have to execute a formal agreement on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.

21) The undersigned is not bound to accept the lowest quotation and reserves the right to accept or reject any or all quotations, as the case may be without assigning any reason whatsoever.

22) Quoted rate shall be inclusive of all charges including royalty, VAT, tools charges, transportation etc.

23) All the quotaioner have to submit required test certificate for all the materials & work done.

24) At least 3(three) papers are required to fulfill the quotaion procedure.

25) Material testing report should be submitted by the quotaioner before claiming of bills.

26) All quotaioner should abide by the rules & regulation of ESMF.

27) Payment may be delayed due to insufficient fund of MGNRES.

28) Quotaioner should strictly follow the latest order regarding GST.

29) During verification if any manipulation /discrepancy found in Technical documents, then his paper will be cancelled and the quotaioner will be black listed for 03 years and step will be taken as per norms

30) All rates are inclusive GST rate. All quotaioner have to submit proper GST Bill with Challan before claiming of Bill

31) The application for the works along with all relevant papers mentioning Quotation No. & Sl. No. of the work clearly shall have to be mentioned otherwise it will not entertained.

32) All works will have to be done according to specification and drawing approved by the authority and as per direction of Pradhan, Brindabanpur G.P. No consumable material and no working tools & plants will be supplied from this office to the Agency. The Agency is fully responsible for arranging the same at his own cost.

33) Before submission of quotaion the contractor/supplier must visit the work site to judge the local condition from all corners and no plea/complain about the site will be entertained afterwards. It will be presumed that the agency offered the quotaion after reviewing entire position of the work site where supply is to be made.

35) Acceptance of lowest rate is not obligatory and the undersigned reserves the right to accept or reject any or all of this Quotation.

36) Affidavit of the quotaioner has to be submitted with the quotaion form, without it his quotaion form will be canceled.
