4. All duties, taxes, royalties, labour cess, GST[including 1% Labour Cess under W.B. 5. The applicant in the same name and style as prime contractor should have successful competed at least one contract of similar type Civil Engineering works to a value of 50% of estimated cost in a single tender completed within last 5 years, from the Govt. / Semi Govt. Organizations.
6. Each Bidder should have in any one year minimum financial turnover during the last 5 years (in all cases of civil engineering construction works only) volume of construction work of at least the amount equal to the 50% of the estimated cost of work. The turnover will be indexed at the rate of 8 percent simple interest for a year. (The respective payment certificates are to be attached).
7. Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity for construction work is equal to or more than the total bid value. The available bid capacity will be calculated as under.
 - a. Assessed Available Bid capacity = $\{A*N*M-B\}$
Where
A= Maximum value of civil engineering works executed in any one year during the last five years (updated to the price level of the last year at the rate of 1 percent simple interest a year) taking into account the completed as well as works in progress.
N = Number of years prescribed for completion of the works for which bids are invited (period up to 6 months to be taken as half - year and more than 6 months as one year).
M=3
B = Value, at the current price level, of existing commitments and on-going works as completed during the period completion of the works for which for which bids are invited.
- Note : The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer- in- charge, not below the rank of an Executive Engineer or equivalent.
8. The bidder should submit the original documents for verification at the time of Bid Opening.
9. Successful tenderers will have to execute an agreement with the Pradhan, Radhapur Gram Panchayat on a non judicial stamp paper valued Rs. 100/- (One hundred only) within the date specified in the letter of intimation. The successful bidder shall submit balance earnest money @2% at the final awarded cost before issue of the work order-
10. Tenderers must submit requisite credential certificates from Appropriate Authority.
11. Contractors shall have to comply with the provisions of (a) The contract labour (Regulation appellation) Act, 1970(b) Apprentice Act, 1961 or (c) Minimum wages Act, 1948 and the notification thereof by other laws relating to tire rates and rules made and issue hereunder from time to time.
